Adopt election schedule for Non-Chiefs District III

Motion by Mr. King seconded by Mr. Calloway to adopt the election schedule for one trustee position to represent Non-Chiefs District III (New Orleans) for a five-year term beginning July 1, 2019 and ending June 30, 2024. Without objection, the motion carried.

Investment Consultant's Report

Mr. David Barnes represented NEPC and presented the Investment Market Update for the system. The total market value as of March 31, 2019 was \$2,082,579,990 and performance was up 0.7% for the month and up 0.7% for the fiscal year to date.

INTECH

Mr. Warren DeKinder and Mr. Richard Yasenchak represented Intech Investments and presented its annual report to the board. The market value as of March 31, 2019 was \$137,800,312.

Discussion of 2019 Regular Legislative Session Bills

Mr. Huxen provided an update on relative retirement bills progressing through the legislature.

SB16 – by Senator Gerald Long, provides for self-directed DROP funds, was heard in Senate Retirement Committee and is scheduled to be heard on senate floor later today, April 17, 2019.

HB14 – by Rep. Barbara Carpenter, prohibits persons from rejoining FRS or MPERS while he is employed by the same employer or any other employer whose employees are covered under the federal Social Security program. The House Retirement Committee is scheduled to meet April 25, 2019.

HB22 – by Rep. Tony Bacala, provides for certain overtime payments made by BRPD to employees who are members of MPERS to be included in the calculation of average final compensation for eligible members. The House Retirement Committee is scheduled to meet April 25, 2019. Discussion was held regarding amendments of this bill.

Motion by Mr. Reech seconded by Mr. King to support an amendment that would give Baton Rouge credit for the actual market rates of return on system assets earned by

MPERS that are attributable to the disputed overtime contributions. Without objection, the motion carried.

Discussion of finding of disability for Blake J. Munster (New Orleans). May be heard in executive session, without the disability applicant present, under the provisions of R.S. 42:17(A)(10) to facilitate privileged communications under La. Code Evid. Art.506

Motion by Mr. Reech seconded by Mr. Burkart approve the non-duty related disability application for Blake J. Munster (New Orleans) as certified by MPERS's board-designated physician. Without objection, the motion carried.

Executive Director and General Counsel Comments

Mr. Huxen provided the board with a list of invoices paid by the retirement system during the prior month for their review. The board had no questions regarding any payments issued.

Mr. Huxen provided the board with a list of all retirement and DROP applications that have been processed since the prior month for their review.

Mr. Huxen reminded the board to file their individual ethics reporting by May 15th, as required by the state.

Mr. Reech inquired about SB14 regarding term limits for retirement system boards of trustees. Mr. Huxen reported that the bill was heard in committee but had opposition.

Mr. Huxen provided an update to the implementation of the new pension administration system. He stated that MPERS is at 38% of completion of the work schedule which is 1% ahead of schedule. We are currently working on the employer reporting file formats.

Mr. Huxen provided the operating budget for the third quarter and reported that all line items are in order and no adjustments are needed.

Motion by Mr. Reech seconded by Mr. King to adjourn the meeting at 10:25 a.m. Without objection, the motion carried.
