NEPC Report on Investments

Mr. David Barnes represented NEPC and first presented the Investment Market Update for September. The total market value of the portfolio as of October 31, 2020 was \$2, 268,156,489 and performance was down by 0.8% for the month but was up by 4% for the fiscal year to date. Mr. Barnes also provided an educational presentation on the market summary, performance, and manager updates. He updated the Board on several staff changes, as well as the status of several funds in which they have invested

Actuarial Comments

Mr. Greg Curran noted that he doesn't have much to report. The actuarial valuation has had a few delays and will be presented at the December meeting.

Executive Director and General Counsel Comments

Mr. Huxen updated the Board on the PATROLE project. The system has been live and the member portal should be done in mid to late December. He also provided a summary of what members will be able to do in the member portal.

Next, he updated the board on the delinquent municipalities. There are still a few outstanding but staff is working with them to sort out issues.

Other Business
